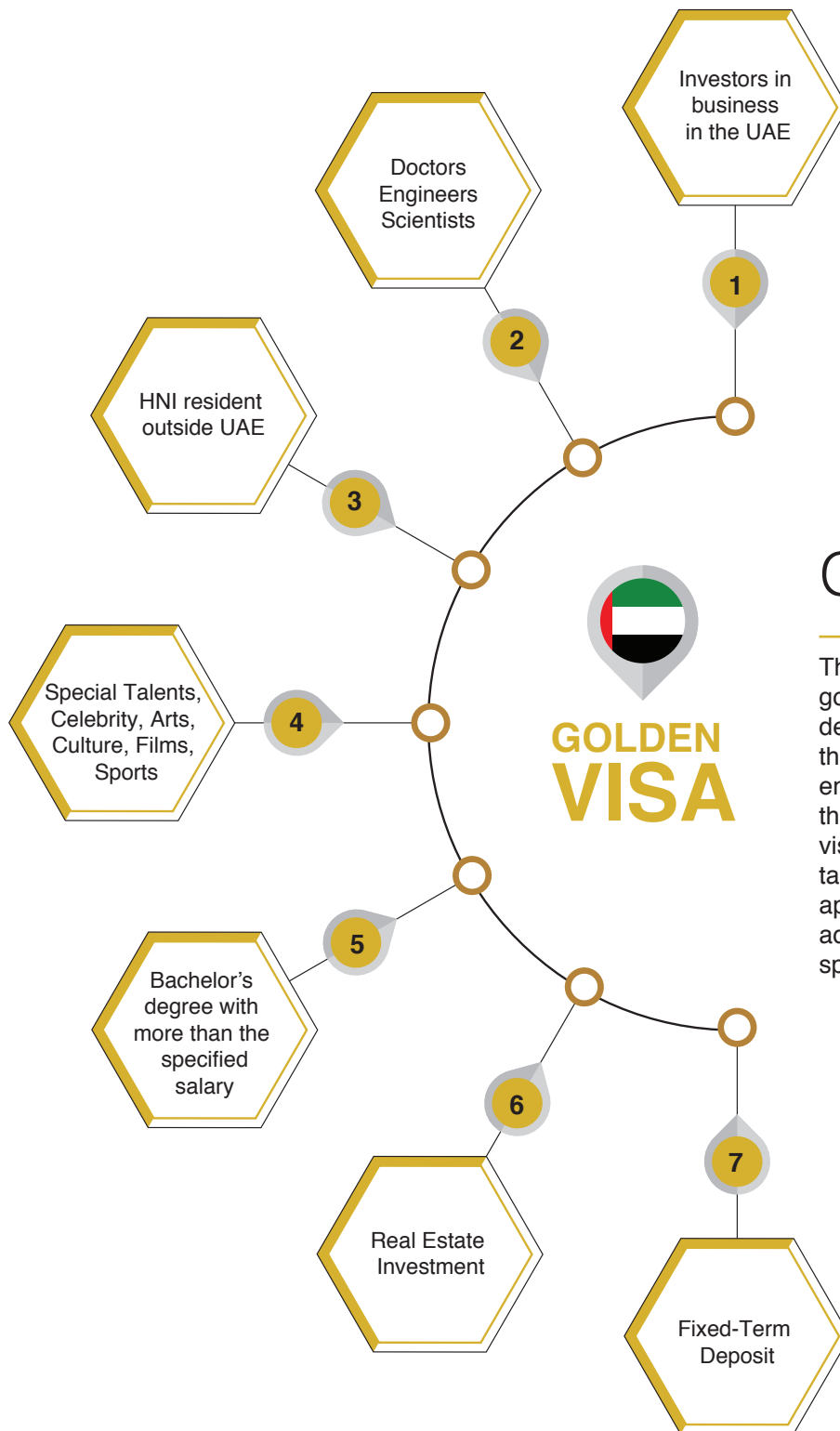

UAE GOLDEN VISA

The recent revamped of the UAE's golden visa rules has increased its demand. Many such changes to the Golden Visa programme have enabled more individuals to make the cut for the coveted 10-year visa. Aspiring applicants now must take advantage of the golden visa application because it has several advantages, it opens-up a broad spectrum of categories.

INVESTORS IN BUSINESS IN THE UAE

A person who invests in any commercial companies in the United Arab Emirates (UAE) with a share capital of more than AED 2 million and meets certain other requirements is eligible for the golden visa.

DOCTORS / ENGINEERS / SCIENTISTS

A special category designated for professionals like doctors with DHA medical licences, engineers with municipal licences, scientists with affiliations having government recognition to practice are eligible for a 10-year golden visa validity if specific prerequisites are met.

HNI RESIDENT OUTSIDE UAE

Golden visa applicants who earn more than AED 35,000/- per month and have an investment outside the UAE of more than AED 2 million can apply for an invitation from the Dubai Government to acquire a golden visa, subject to approval.

SPECIAL TALENTS, CELEBRITY, ARTS, CULTURE, FILMS, SPORTS

Candidates for the golden visa must be talented, highly skilled, and well-identified individuals whose profiles are available and accessible to the public media are qualified to apply for the golden visa.

BACHELOR'S DEGREE WITH MORE THAN THE SPECIFIED SALARY

The golden visa is available to bachelor's degree holders with a monthly salary of AED 30,000/- with two (2) years old contract and five (5) years of consistent employment with the same company.

REAL ESTATE INVESTMENT

If the investor has a property worth more than AED 2 million in the UAE, he/she may be qualified to apply for the golden visa.

FIXED-TERM DEPOSIT

The person must have a fixed deposit or investment of AED 2 million or more, for a minimum period of 2 years.

ADVANTAGES OF GOLDEN VISA

- Limitation of visit to the UAE for every six (6) months is waived.
- Application for Tax Residence Certificates (TRC) if you stay in the UAE for more than ninety (90) days
- 100% shareholding of the company with specific activity
- Sponsorship of Family valid for 10 years
- Sponsorship of Parents valid for 10 years
- Sponsorship of Housemaids and Drivers (there are no numerical limits)
- Eligibility for certain Government approved privilege cards
- Employment in any company by just processing a labor card
- Prospective opportunities and additional benefits to be announced by the government such as insurance scheme, special queue arrangement, among other things



Importantly, long-term residency is now available to more qualified professionals with a minimum monthly salary criterion of AED 30,000 as opposed to AED 50,000. Candidates must be classed in the first or second occupational level who holds a bachelor's degree according to the Ministry of Human Resources and Emiratization and have a current work contract in the United Arab Emirates with more than the specified salary.

People from all over the world are flocking to the UAE to buy real estate as the demand grows. The minimum investment required for a person to be eligible for the golden visa has been reduced to AED 2 million from AED 5 million by the authorities.

As anyone is eligible to apply for the golden visa, he/she may approach the relevant institutions, notably the General Directorate of Residency and Foreigners Affairs Dubai (GDRFA) and/or knowledgeable firms such as SUN Management Group, who will assist you in processing and obtaining the golden visa.
